**AND - Please be sure that your membership is and will be current during damp week.**

The REFRIGERATOR page - keep this page for your information.

Please bring your child to the first day of camp on June 14 shortly before 9 am. Please stay with your camper until our Camp Director, addresses the group. There will be a short explanation about the traffic pattern, highway safety, pick-up times (12:30), places, etc. After the first day, you may drop your children at the front door. We will be there to greet them. Concerning pick-up – Campers who have the pottery barn class last will be given special instructions. All others will “fit” in the drive way if you keep close to the car in front of you, so we don’t have parents waiting out on the highway in the left turn lane.

In the event your plans change, please notify us immediately. It is expected that other children will be on a waiting list and that we may be able to replace your child if enough notice is given. We cannot guarantee a refund if time does not allow us to replace your child with a standby.

Classes will be held inside the Art Center (air conditioned), in the Crafts Barn, and outside (weather permitting). The Campers should dress comfortably with the possibility of getting messy. **Please do not wear clothes that would be inappropriate for getting “art” on them!** They will be working with paints, dyes, clay, etc. Campers should not bring anything with them. All of the art materials will be included.

SNACKS – A snack will be provided for your camper. If your camper has special needs for a snack, please provide the snack. Also campers are not required to eat the snack. For example, if you don’t like vanilla pudding – don’t take it and immediately throw it away – simply don’t take it.

Campers are expected to behave properly while at camp. Inappropriate behavior can result in expulsion from camp and no refund will be given. We’re here to have fun with art – not throw drink boxes on each other.

Please keep in mind the Summer Art Camps are sponsored by individuals, businesses and corporations. In order to keep the cost for families down, please continue to support the arts with your dues and donations.

### And the most important point:

“Mom! Look at what I did!” “Dad! My art teacher said I was pretty good at this.” Sharing enthusiasm is a very important part of the camp experience. Ask your camper, “What did you do today? Can I see it?” Students will be bringing items home each day. Brag on them. It is expected that the pottery barn project may not be finished by the last day of camp. Come back with your child to pick up this project as instructed. It is important to your camper!

\* We are flexible with our age groupings. If a student attend the K-1 camp last year, they are welcome to attend the grade 2-5 camp. Or simply if transportation is easier with an older sibling also attending, then the student is welcome even though they might be a kindergartener.
